III. MAINTENANCE AND REPAIR OF APARTMENTS

2. By the Apartment Owners. The responsibility of the Apartment Owner shall be as follows:

(e) not to make any alterations in the portions of the Apartment or the Building which are to be maintained by the Association or remove any portion

thereof or make any additions therete or do anything which would or might jeopardize or impair the safety or soundness of the Building without first obtaining the to the Common Elements. Limited Common Elements or portions of the Apartment visible from the exterior of the Apartment, without the advance written consent of the Board of Governors, of the Association and all first mortgagees of individual units, nor shall any Apartment Owner impair any easement without first obtaining the written consent of the Association and of the Apartment Owner or Owners for whose benefit such easement exists. Additionally, no Apartment Owner shall make any alteration to or addition to the interior of an Apartment which might jeopardize or impair the safety or soundness of the Building. Any plans to renovate or remodel an Apartment which involves demolition, drilling into the slab, removing walls which involves electrical or plumbing work must be approved in advance by the Board of Governors and is subject to further Board Rules and Regulations regarding engineering requirements.

Notwithstanding the foregoing, the Board will not approve the removal of or sealing of secondary doors to the Apartments by Owners with the sole exception of approving the removal or sealing of those doors in the 9 stack which occurred prior to this amendment.
